Serving the Community

Even when on the clock, driving a bus for the North Central Alabama Regional Council of Governments (NARCOG) Regional Transit Agency, Jerry Barnette still looks for ways to help serve his community.

While driving his NARCOG Transit route in March, Barnette noticed that a passenger had a wheelchair ramp at her home that needed repairs. When Barnette returned to NARCOG later that afternoon, he immediately inquired with the Area Agency on Aging (AAA) if there were funds available to assist with re-

Utilizing Title III-B grant funds, available through the Older Americans Act, NARCOG helped fund the repair of the wheelchair ramp with the assistance of Decatur First Baptist Church.

"With our Title III-B funds, NAR-COG can help pay for small projects that are labeled as a 'Chore," Area Agency on Aging Director Justin Graves said. "Helping build a wheelchair ramp falls under that 'Chore' category.

"Our agency also is grateful for employees like Jerry. He identified that a client had a need and went the extra mile to make sure she received assistance."

Older adults in Cullman, Lawrence and Morgan counties who need assistance with small projects that could help improve their quality of life should contact the NARCOG Aging and Disability Resource Center (ADRC) to see if they qualify.

"For this fiscal year, we have Title III-B funds set aside solely for projects that qualify as a 'Chore' under the Older Americans Act," Graves said. "Last year, our AAA spent \$15,000 through this program, building 11 wheelchair ramps for older adults in the Region.

"These projects really do make a positive impact on the lives of older adults in our community."

The Dementia Friendly Alabama (DFA) Memory Café is a relaxed social gathering open to anyone affected by memory loss or related cognitive changes. The DFA Memory Café is designed to make people with dementia feel comfortable and successful.

For caregivers and care partners,

the Café is a much-needed break; and a chance to have fun together without focusing on the disease. The most recent Café activities included Garden Bingo and pottery painting for participants to enjoy.

Several Decatur High School students were able to participate in the Virtual Dementia Tour (VDT).

VDT is described as "your window into their world." Participants wear patented devices that alter their senses, and trained facilitators guide them while they try to complete typical everyday tasks.

The tour allows participants to experience the physical and mental challenges that people with dementia may face. VDT has been implemented by over 2,000 facilities and shared by millions of people worldwide. This dementia simulation is evidence-based, with proven results and outcomes.

This proposed project aims to bring comprehensive, wraparound entrepreneurial services to our partner communities by delivering coaching and education for existing entrepreneurs, helping them create and retain jobs in a challenging time which now includes inflation as a relevant factor. erating in these communities and those that are brought in.



NARCOG Transit strives to provide reliable transportation in the Decatur urban area. It's understood that reliable and safe transportation is essential for individuals to stay independent and healthy in their community. NARCOG Transit is continuously looking for new ways to improve transportation for our community and recently conducted a Public Interest Survey to better understand the needs of the public. The survey revealed that more people are interested to use public transit service three or more times

a week for work and school If convenient public transit service were available near their home. As shown in the chart, more than 50% of all trips scheduled by NARCOG transit are carrying people to and from work regularly. NARCOG Transit has organized a meeting on Thursday, April 13th, 2023, from 4:00 PM to 6:00 PM at the Turner-Surles Community Center.
