## **Planning Continues Grants Administration**

The NARCOG Planning Team continues to provide grant administration for community and economic development projects totaling over \$6M in Falkville, Colony, Garden City, Lawrence County, Moulton, the Decatur-Morgan County Port Authority, and the Lawrence County Board of Education.

These projects, funded by the Appalachian Regional Commission (ARC) and the Community Development Block Grant (CDBG) program, make a significant difference in our community. # **Home and Community Based Services**

The Medicaid Waiver Home and Community-Based Case program is a significant initiative designed to provide services for elderly seniors and disabled individuals. The program allows them to live comfortably in their homes and communities they love, rather than having their needs met in a long-term care facility. This person-centered case management,

personal care, homemaker, and other services are provided at no cost to the individual or their family, ensuring their well-being and independence.

The Medicaid Waiver covers several programs, including the Elderly and Disabled (E&D) Waiver, Personal Choices, Gateway to Community Transitions (GCL), Alabama Community Transition Waiver (ACT), and the Hospital to Home Program. Each program is slightly different and helps to cater to the covered individual's needs.

NARCOG currently serves over 600 individuals in Cullman, Lawrence, and Morgan County.

The NARCOG Transit Agency operates an urban public transportation system within the Decatur Urban Area. The purpose of this service is to provide mobility opportunities to individuals of all ages and abilities in collaboration with the City of Decatur and the Federal Transit Administration.

- Wheelchair-accessible vehicles are available
- Each one-way ride costs \$2
- Connect Cards (prepaid punch cards) can be purchased at the main office or on a transit vehicle for \$20
- Ride Operations are Monday through Friday from 7 AM to 5 PM
- Ride Scheduling is Monday through Friday from 7:30 AM to 4 PM
